Meals on Wheels Update:

The Council started running the Meals on Wheels on the week starting the 30th March 2020 on a five day a week basis and continued to run at this level until the Luncheon Club re-opened on the 3rd October 2021.

Provision and staffing for the Meals on Wheels was discussed with staff at this time and it was decided to reduce the Meals on Wheels to Monday-Thursday from the week ending 1st October 2021. The provision was reduced further on the 3rd December 2021 to Tuesday, Wednesday and Thursday with a view to winding down the service.

The users of this service were predominately Barrowford residents with an age range of 70 to 99 years old nearly all living alone with either health or mobility problems. The service has continued at this reduced rate against a backdrop of reduced users through either death or going into permanent care.

There is still a need for Meals on Wheels provision but unfortunately Barrowford Parish Council is probably not the best suited provider through diminished demand at a Barrowford level. The Clerk spoke to Pendleside Hospice some time ago but due to Covid restrictions demand was high with a waiting list. The Clerk has spoken several times to the Chairman about the future of the Meals on Wheels.

Having finished the accounts for the year 2021-22 it has become obvious that things will have to change. The Clerk spoke to the Catering Manager at Pendleside Hospice on the 10th May and currently they have spare capacity to provide meals seven days a week at a cost of £6.75 per day. Although this rate is currently higher than what Barrowford Parish Council charges the Parish Council has been operating on a grant subsidised scheme but unfortunately that funding has now been spent.

As can be seen from the figures the Meals on Wheels is now running at a loss to move it to beak even would mean increasing prices in line with the Hospice, but if numbers continue to decline then the service would become unsustainable. The ceasing of the Meals on Wheels would have a detrimental effect on the Luncheon Club as numbers have diminished to around 12 per week.

Recommendations to the Council:

- That the Council resolve to end the Meals on Wheels.
- That a six weeks grace period is given from the letter of withdrawal of the service being delivered to users, with the Hospice be promoted as an alternative source.
- That the Council understands that the final losses could be around £1,000.
- That the Luncheon Club is supported until such time as attendance increases.
- Wages for Luncheon Club staff are already included in the budget so no review is necessary until the budget setting process for 2023-24 begins.
